Dear parents/carers,

- Lunch
- Recess – there may also be a canteen open on the day (to be confirmed by organising school)

Students will need to wear their **red** Burke Ward t-shirt, black shorts or pants and appropriate footwear. Students will be provided necessary cricket equipment. They may also bring their own cricket equipment.
